

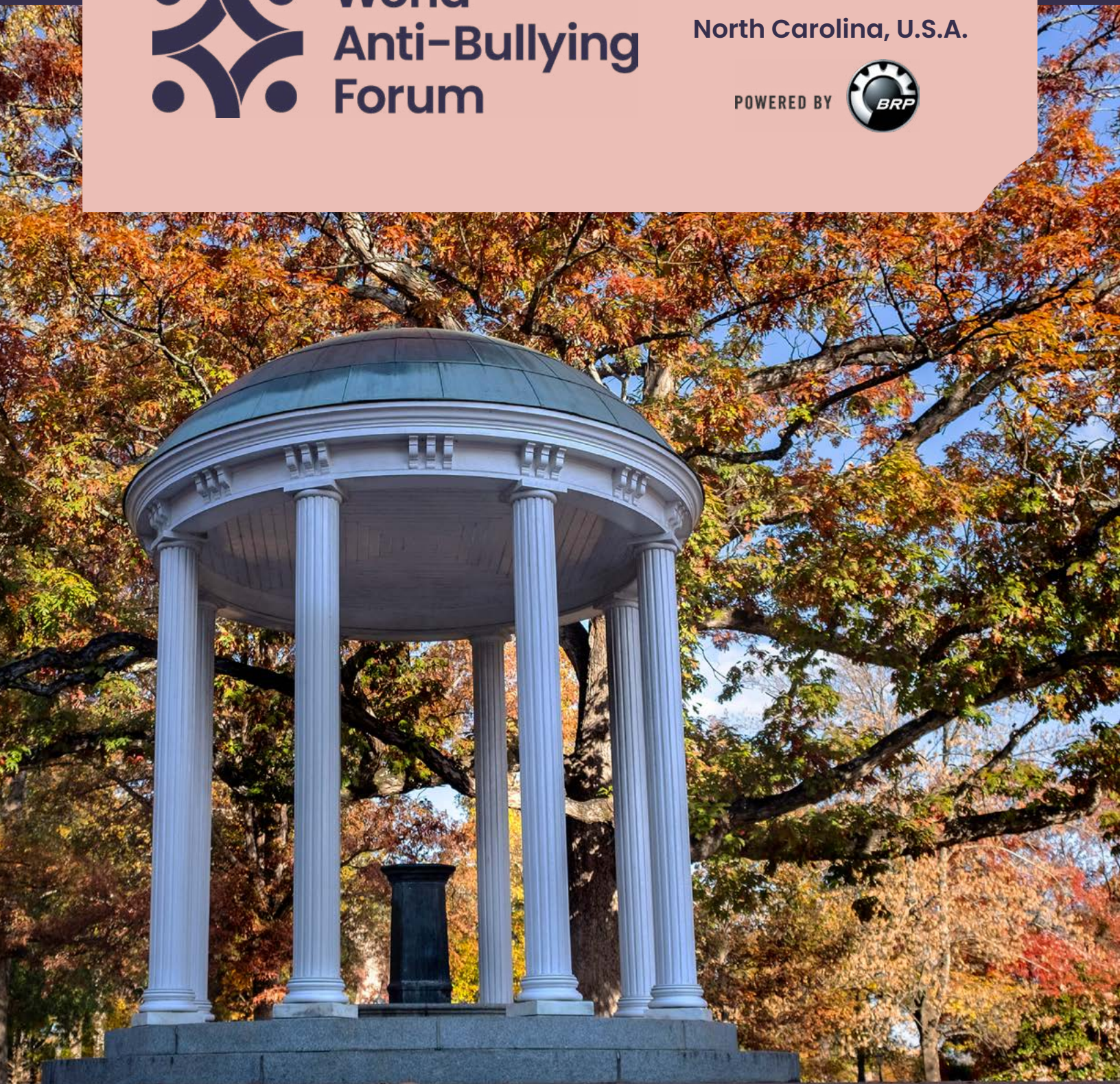

**The World Anti-Bullying Forum is a meeting place for researchers, practitioners, and policymakers in the work against bullying. To end violence against and between children, the Swedish NGO, Friends, initiated the World Anti-Bullying Forum in 2017.**

The aims of the World Anti-Bullying Forum are:

- To address and prevent bullying and other forms of violence among children in accordance with the Convention on the Rights of the Child and Agenda 2030.
- To facilitate the sharing of knowledge and best practices among researchers, policymakers, and practitioners on preventing bullying among children.
- To gather, coordinate, and make research-based knowledge on preventing bullying among children easily accessible globally and digitally.

The World Anti-Bullying Forum is committed to upholding and promoting the rights of all children, as outlined in the Convention on the Rights of the Child. We believe in creating a safe and inclusive environment for all children, regardless of their sexual orientation, gender identity, religion, color, sex, language, political or other opinion, national, ethnic, or social origin, property, disability, birth, or other status. This means that all children have the right to enjoy their rights without discrimination of any kind.

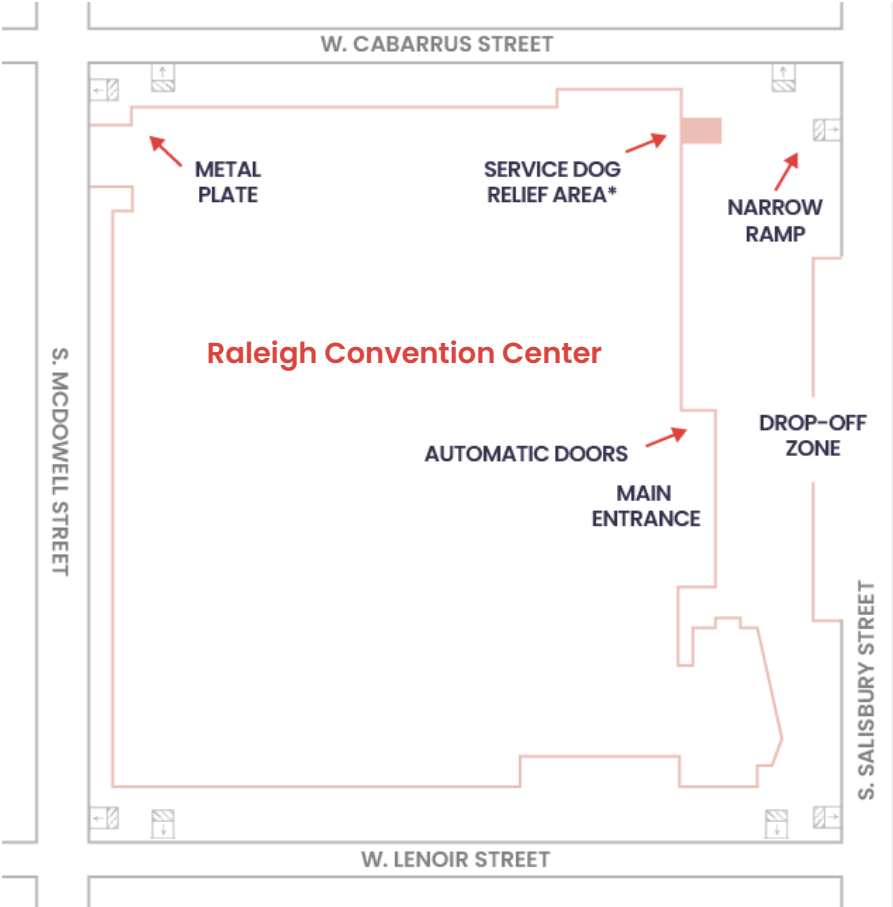

## Location Map — Downtown Raleigh

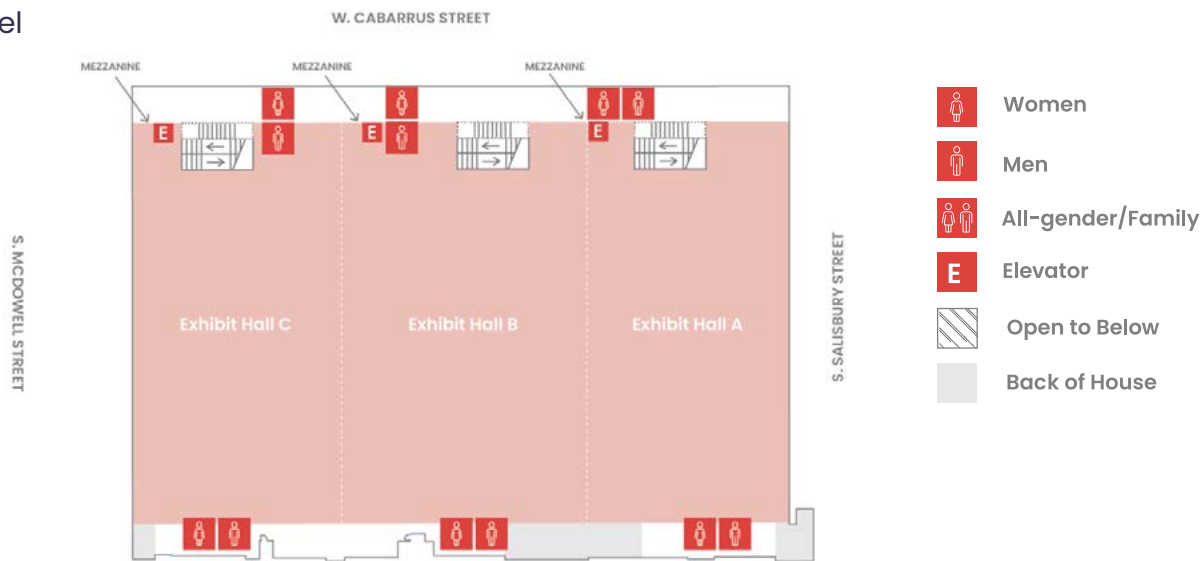


Main Entrance

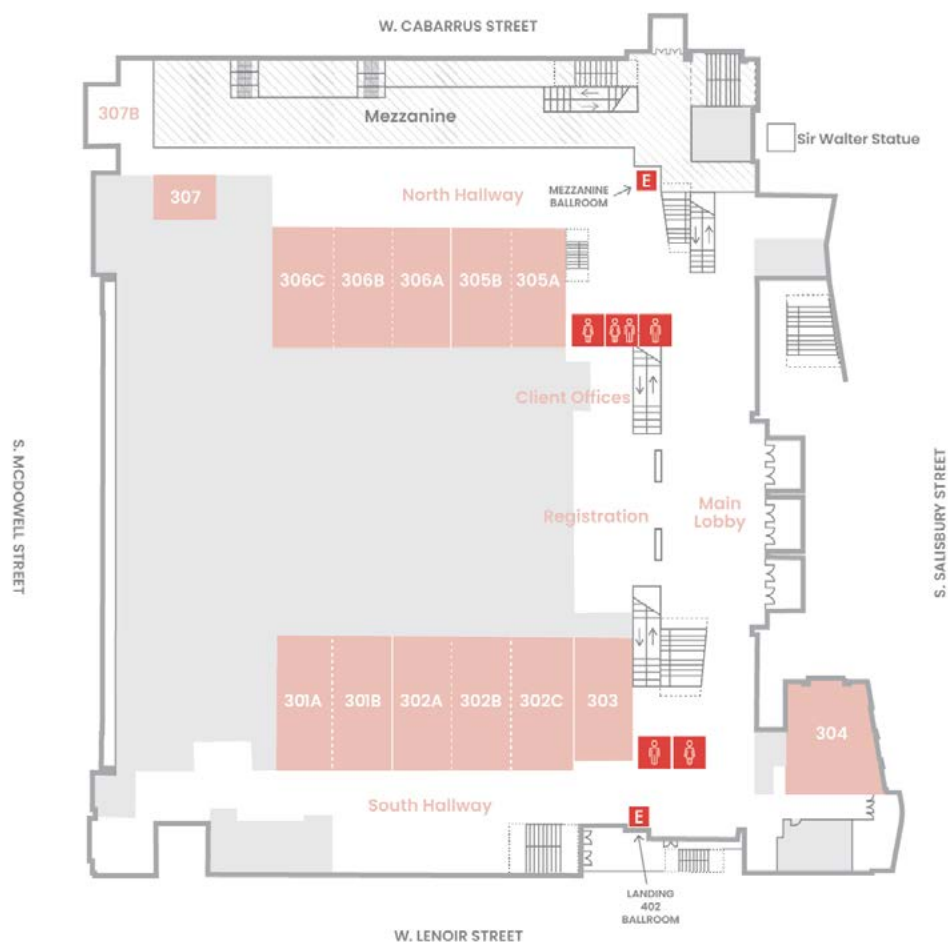

(100-level)



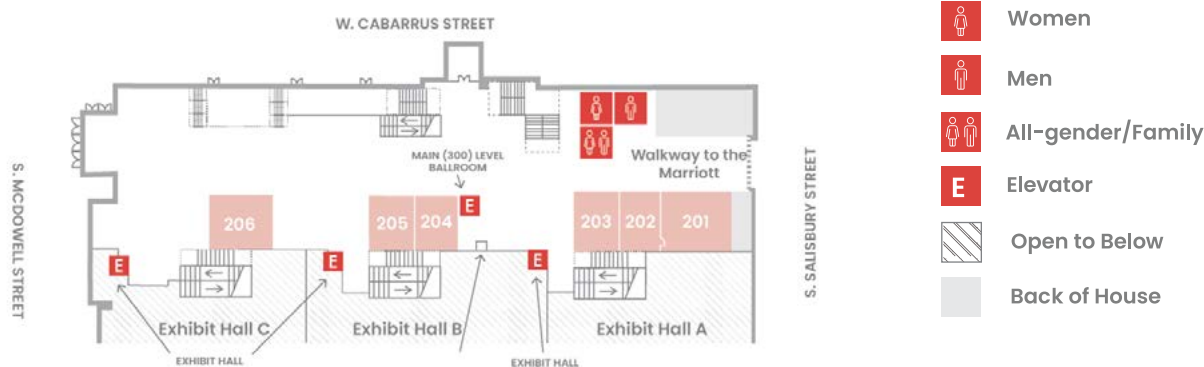
Main Level  
(300-level)



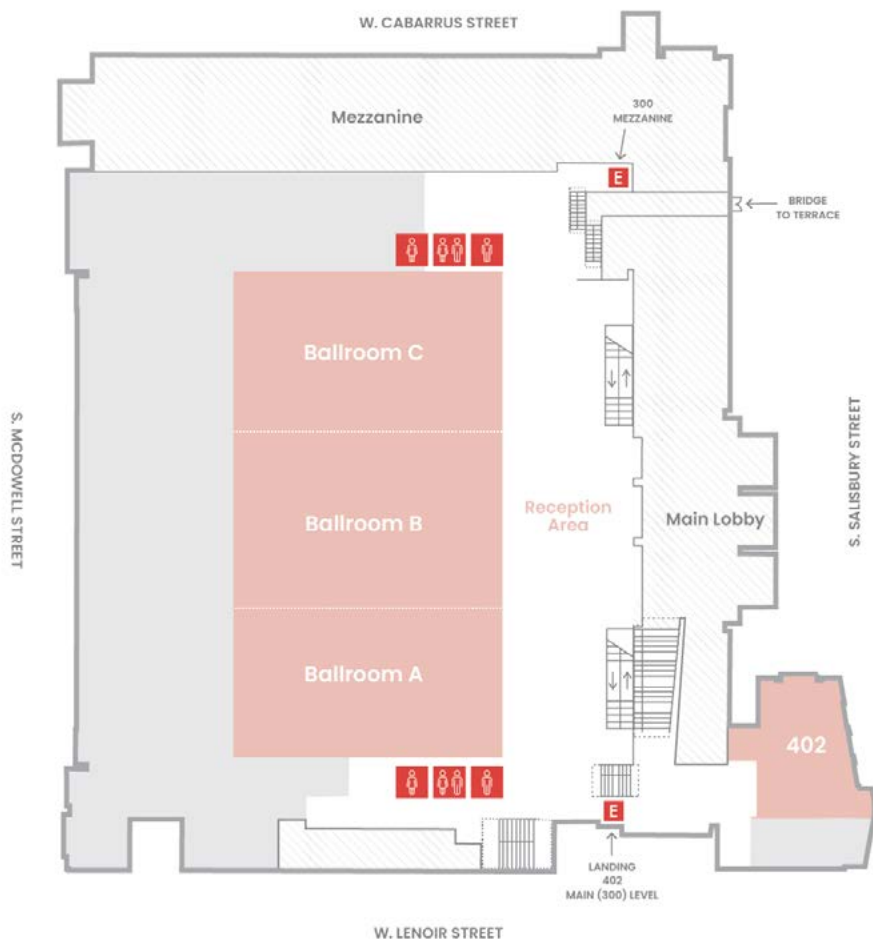


# Raleigh Convention Center Floorplan

# Keynote Speakers



## Enrique Chaux

Professor of Psychology  
Universidad de los Andes in Colombia

---

**Keynote Title: ¿Top-down or bottom-up?: Insights from 20 Years of Socio-emotional Policies to Prevent Bullying in Colombia**

Enrique Chaux, Ph. D., is a professor in the Department of Psychology at Universidad de los Andes in Colombia. He holds a doctorate degree in Education from Harvard University, a master's degree in Risk and Prevention from Harvard, and a master's degree in Cognitive and Neural Systems from Boston University. Chaux's main research interests are prevention of aggression, school violence, citizenship competencies, socio-emotional development, conflicts, bullying, cyberbullying, peace education, and humane education. He led teams that created the Colombian National Standards of Citizenship Competencies, the National Test of Citizenship Competencies, and the school-based program Aulas en Paz (Classrooms in Peace). He has advised the Colombian government on topics related to peace education, school violence, and citizenship education. In 2012, he was awarded as one of the best leaders in Colombia.



## Heng Choon "Oliver" Chan

Associate Professor of Criminology  
University of Birmingham

**Keynote Title: The Victim-Offender Overlap in Bullying and School Violence: A Psycho-Criminological Perspective**

Heng Choon "Oliver" Chan, Ph.D., is an associate professor at the University of Birmingham in the United Kingdom. He was previously affiliated with City University of Hong Kong. He holds a doctoral degree in Criminology from the University of South Florida and was a recipient of the Outstanding Criminology Ambassador Award in 2012 and Distinguished Alumni Award in 2021. His research focuses on psycho-criminology, sexual offending, cyberbullying, bullying, and stalking. To date, Chan has been presented with a total of nine awards to recognize his exemplary contributions to research and professional education. He has published over 100 peer-reviewed journal articles and book chapters; and has sole-authored and lead co-edited seven academic books on different psycho-criminological topics, including Asian and African mental health and the criminal justice system, sexual offending and homicide, stalking, and animal abuse. He is the editor of The Wiley Series in the Psycho-Criminology of Crime, Mental Health and the Law; and section, senior, and associate editor of six top-tier journals in criminology and forensic psychology and psychiatry.

# Keynote Speakers



## Moses Okumu

Assistant Professor  
University of Illinois, Urbana-Champaign

---

**Keynote Title: Collaborative and community-grounded research to address youth victimization in Africa**

Moses Okumu, Ph.D., is an assistant professor at the School of Social Work at the University of Illinois, Urbana-Champaign, and an adjunct professor at the School of Social Sciences, Uganda Christian University. He holds a doctoral degree in social work from the University of Toronto. Okumu's research focuses on developing, implementing, and evaluating interventions in marginalized communities. He seeks to understand and respond to drivers and co-occurrence of the triple health burden (i.e., infectious diseases [e.g., HIV/STIs]; non-communicable diseases [e.g., depression] and violence and injuries [e.g., youth violence]) that can affect the sexual health of youth facing multiple forms of adversity, including poverty, forced displacement, and HIV. His current research focuses on developing and evaluating digital interventions that further HIV prevention cascades and prevent sexual and gender-based violence among mobile youth populations in Uganda. Experienced with collaborative and community-engaged approaches, he has worked with communities in Uganda, Ghana, Kenya, and Canada to address local needs in ways that utilize and further strengthen existing networks.



## Debra J. Pepler

Officer of the Order of Canada

---

**Keynote Title: Moments Matter: A Shift in School-based Bullying Prevention with a Developmental-Relational Perspective**

Debra Pepler, Ph.D., is a distinguished research professor at York University. She holds a doctoral degree in Psychology from the University of Waterloo. Her research focuses on relationships within the family and peer group, with a growing interest in the importance of healthy relationships for healthy development. She developed an innovative observational method to study aggression, bullying, and victimization. Her research on peer and family relationships has been embedded in interventions: Breaking the Cycle for substance-using mothers and their young children, Bullying Prevention with the Toronto Board of Education, SNAP (Stop Now and Plan) for aggressive children and their parents, Pine River Institute for youth with addictions and mental health problems, and the Canadian Red Cross for violence prevention in Indigenous communities. Pepler co-founded and co-led PREVNet (Promoting Relationships and Eliminating Violence Network) to promote healthy relationships and prevent bullying for children and youth.

## Kevin Runions

Head of the Schools and Community Wellbeing  
Telethon Kids Institute

---

**Keynote Title: Humans Implement Bullying Prevention Programs, Too! Steps to an Ecology of School Action**

Kevin Runions, Ph.D. (Human Development & Education, OISE/UToronto) is the Area Lead Consultant for Research, Evaluation & Monitoring with School Mental Health Ontario, which supports the 76 school boards in Ontario — serving over 2 million elementary and secondary students — to implement multi-tiered, identity-affirming student mental health interventions, and is an adjunct professor with McMaster University in Hamilton, Ontario and an adjunct research fellow with the University of Western Australia. He was formerly Head of the School and Community Wellbeing team at Telethon Kids Institute in Western Australia. Dr Runions has conducted research across the biopsychosocial model addressing bullying, aggression, and dysregulated behavior problems, with a passion for understanding the factors that enable young people to bully others, including emotional, motivational, and volitional contributors. He is also interested in how schools can work better to prevent and respond to bullying, support student mental health and wellbeing, and how they can best implement sustainable interventions. He is on the council of the International Society for Research on Aggression and serves on the editorial boards of Aggressive Behavior, the Journal of Youth and Adolescence, and the Journal of Psychologists and Counselors in Schools.



## Christina Salmivalli

Professor of Psychology  
University of Turku

---

**Keynote Title: Bullying prevention: From celebrating success to analyzing failure**

Christina Salmivalli, Ph.D., is a professor and the deputy head of the INVEST flagship research center, at the University of Turku. She holds a doctoral degree in Psychology from the University of Turku. Salmivalli has conducted research on school bullying and its evidence-based prevention for three decades. She has published widely on children's peer relations and bullying in top-tier scientific journals. Salmivalli's team developed the KiVa® anti-bullying program, which has been evaluated in large-scale trials and is currently being implemented in Finland and more than 20 other countries. Salmivalli received the Finnish Science Award in 2017. The award is granted by the Ministry of Education, Science, and Culture based on the proposal of the Board of the Academy of Finland, in recognition of significant scientific achievements. In 2020, she was a recipient of the European Research Council's Advanced Grant for a 5-year project to study the most challenging cases of bullying. In 2021, Salmivalli received the European Association for Developmental Psychology's William Thierry Prayer Award for excellence in research on human development.

In 2007, the Crown Princess founded The Mary Foundation with the mission of fighting social isolation. Under her leadership, the foundation brings together untraditional partners to develop and manage projects and programmes that focus on prevention, the creation of opportunities and empowering vulnerable individuals and groups who find themselves socially isolated. The foundation's focus areas are domestic violence, bullying, wellbeing, and loneliness.

The Crown Princess is a passionate advocate for health, gender equality, and the empowerment of women and girls. She is committed to creating awareness and respect and to ensuring compliance with women and girls' sexual and reproductive health and rights, including access to family planning and the reduction of maternal and child mortality. Her Royal Highness is Commissioner of the High-Level Commission on the Nairobi Summit on ICPD25 Follow-up and serves as patron of several international organisations and agencies, including the United Nations Population Fund and the World Health Organization Regional Office for Europe, but also some Danish NGOs: Danish Refugee Council and Maternity Worldwide. The Crown Princess is a frequent speaker at international conferences and an honorary member of various associations and societies.

The Crown Princess and His Royal Highness Crown Prince Frederik have four children – Prince Christian, Princess Isabella, Prince Vincent, and Princess Josephine.



**Greg Richardson**  
Executive Director  
N.C. Commission of Indian Affairs

Greg Richardson serves as executive director of the North Carolina Commission of Indian Affairs and is a member of the Haliwa-Saponi Indian Tribe. As executive director of the Commission of Indian Affairs, Richardson is responsible for the overall administration and oversight of all Commission programs and operations. The Commission administers programs designed to address Indian education, housing assistance, workforce development, domestic violence, and Indian child welfare. He has served the state of North Carolina in a variety of roles since 1975. He brings thirty years of work experience in administration, management, and planning of Indian programs at the state and federal government levels and extensive work experience in the development of collaborations and partnerships with Indian tribes and Indian Associations and non-profit community-based organizations.

# Forum Emcees



**Dorothy Espelage, Ph.D.**

William C. Friday Distinguished  
Professor of Education  
UNC School of Education

Dorothy Espelage, the organizer of the 2023 World Anti-Bullying Forum and William C. Friday Distinguished Professor of Education, is a foremost expert on bullying and youth well-being. For more than 25 years, she has pursued research and evidence-based practices and sought a worldwide network of like-minded collaborators to answer questions that include: How can we prevent bullying? How can we make schools safer? As one of the world leaders in her field, Espelage is credited with introducing the notion that school-based bullying is best understood as a behavior that emerges over time, is maintained as a group phenomenon, and serves as a precursor to other forms of youth violence. Research led by Espelage has resulted in more than 275 peer-reviewed journal articles, 75 book chapters, and eight books, making her one of the world's most-cited scholars in her areas of research. Her work has attracted more than \$16 million in research funding from a range of funders, including the U.S. Department of Education, the National Institute of Justice, and more. Her expertise has been called upon by media outlets that include CNN, Anderson Cooper, Oprah, Huffington Post, and USA Today, and by the White House and Congress. Among numerous accolades, Espelage has been elected to the National Academy of Education and has received the American Psychological Association's Lifetime Achievement Award in Prevention Science and the APA's Award for Distinguished Contributions to Research in Public Policy. She is also a Fellow of the American Educational Research Association, the Association of Psychological Science, and the American Psychological Association's Divisions 15 (Educational Psychology) and 17 (Counseling Psychology).



**Sameer Hinduja, Ph.D.**

Professor  
School of Criminology  
and Criminal Justice  
Florida Atlantic University

Sameer Hinduja is a professor in the School of Criminology and Criminal Justice at Florida Atlantic University, co-director of the Cyberbullying Research Center, and faculty associate at the Berkman Klein Center at Harvard University. He is recognized internationally for his groundbreaking work on the subjects of cyberbullying, sexting, and social media and gaming abuse, concerns that have paralleled the exponential growth in online communication by young people. He has written seven books, and his interdisciplinary research has been cited approximately 22,000 times across fields that include pediatrics, information technology, computer science, business, psychology, education, and nursing. As a noted researcher and speaker on youth and social media issues for the last 20 years, Hinduja trains technologists, educators, mental health professionals, youth specialists, parents, and students around the world on how to promote the positive use of technology and build healthy online communities. Hinduja is frequently asked to provide expert commentary by news organizations, and his work has been featured in venues that include CNN, NPR, the BBC, and The New York Times. He has worked with corporations that include Google, Snap, Twitch, Meta, TikTok, Intel, Johnson & Johnson, Merrill Lynch, Verizon, and Cartoon Network, and organizations that include the United Nations, White House, World Bank, National Guard, National PTA, and Anti-Defamation League on how best to shape policy, programs, and more. He received Auburn University's Global Anti-Bullying Hero Award, won Florida Atlantic University's Researcher of the Year award, presented on cyberbullying at a Congressional Briefing on Capitol Hill, testified in front of the Attorney General and the Departments of Education, Health and Human Services, and Homeland Security, and served as a Fulbright Specialist Scholar at Dublin City University. Hinduja is co-founder and co-editor-in-chief of the International Journal of Bullying Prevention.
